All potential clients will be screened for financial eligibility through Kansas Legal Services. Many of the cases referred will be cases that KLS cannot accept, due to conflict or other barriers. Clients using this program understand that the attorney has agreed to provide services at no cost for the referred case only. Clients also understand that they may be required to pay filing fees, witness fees, etc. You should accept the case with no expectation of payment for your time or office expenses. KLS may be able to help with extraordinary litigation expenses, when the interests of justice require it.
